Your Dental Benefit

Provides you and your covered dependents with **2 Routine Cleanings** per year and associated diagnostics (x-rays). Schedule an appointment if you still have services to use! Your Vision Benefit

Provides you and your covered dependents once every calendar year with an **Eye Examination** (for only a \$10 co-pay if in-network), **Lenses and Contacts**. And **New Frames** once every two calendars year. There is still time for an appointment in 2021 if you haven't used those benefits yet. Submit no later than Thursday, December 23, 2021

If you are one of the few churches still submitting through regular mail:

Submit no later than Friday, December 10, 2021

Please include on the Form the year you want the contribution to be applied.
